



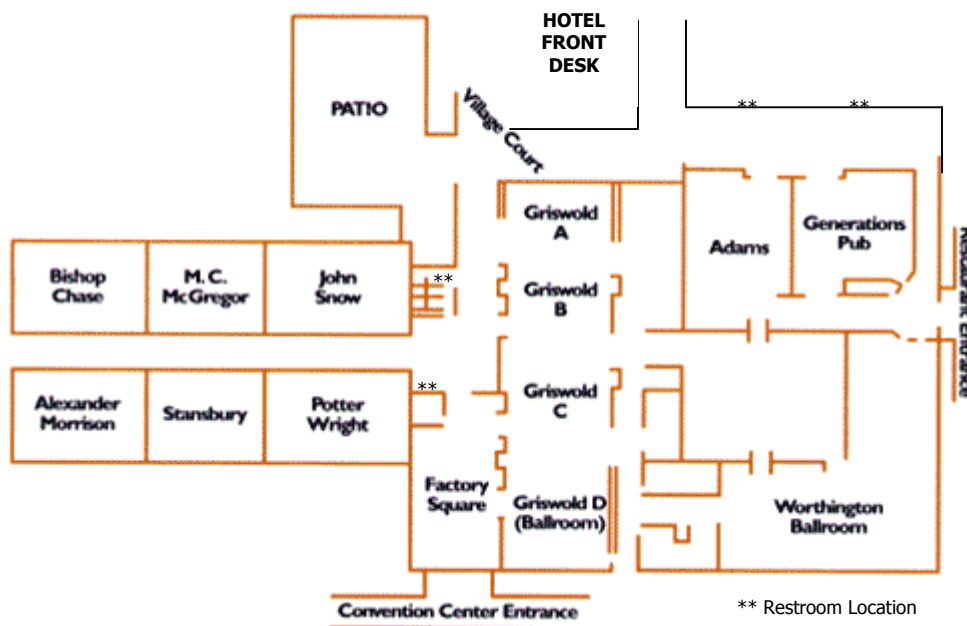

While much literature supports the efficacy of service-learning to achieve these goals, little research addresses the “underside” of service-learning or the challenges students encounter when facing complex social issues (Jones, 2002). This session seeks to discuss student resistance to service-learning using frameworks provided by critical pedagogy and self-authorship (Baxter Magolda, 2002; McLaren, 2003).

The assessment tools were Dr. Jean Phinney's Multigroup Ethnic Identity Measure and an open form questionnaire about NPHC members' knowledge of IFC.

Intervention strategies for facilitating a relationship between NPHC and IFC were developed as means of addressing the results from the assessment. These strategies, as well as others, will be presented during this program.
